# **Labour Party conference**

At the Labour Party conference, the Prime Minister has outlined several of his benefit priorities.

- 'We will get the welfare bill down because we will tackle long-term sickness and support people back to work. We will make every penny work for you because we will root out waste and go after tax avoiders'
- Securing the triple lock State Pension
- 'We will legislate to stop benefit fraud. Do everything we can to tackle worklessness'.
- Introducing a 'youth guarantee that will eradicate inactivity and unemployment for our young people – once and for all'

Following the conference – the government announced that it would bring forward a 'Fraud, Error and Debt Bill in this parliamentary session to crack down on fraud in the social security system.'

### **Household Support Fund extended**

The Household Support Fund has been extended for a further six months. An additional £491 million will be given to local authorities, with separate funding also given to Scotland.

'This funding will work to help those in need. Pensioners and others struggling with the cost of living over the colder months should contact their local council to see what support may be available to them.'

### Winter Fuel Payment – guidance issued

As we are sure you are aware, Rachel Reeves, the new Secretary of State for Work and Pensions, has announced changes to the eligibility criteria for Winter Fuel Payment in England and Wales. From Winter 2024/25, as well as being over State Pension age, you must be in receipt of Pension Credit, Universal Credit, Income Support, incomebased Jobseeker's Allowance or income-related Employment and Support Allowance.

She also announced that the government intend to accelerate the plans to bring together Pension Credit and State Pension age Housing Benefit, which was originally intended to begin in 2028.

# **Support for Mortgage Interest – interest rate change**

From 9 September, the interest rate used to calculate SMI mortgage payments has increased to 3.66%. As a reminder, this is different to the rate that is used to calculate the repayment amounts – currently at 3.9%.

#### Care leaver bill

A Private Members' Bill which seeks to raise the Universal Credit standard allowance to the 25 and over rate for all care leavers has received its first reading in the House of Lords. We will keep you updated with any developments.
